



Looking for an opportunity to help those in need while reducing your state tax bill?

Arizona provides a dollar-for-dollar tax credit on your state tax return for contributions made to these organizations throughout the year.

Here is a list of limits, links to lists of qualifying organizations, and maximum credit allowed based on a taxpayer's filing status for **2024**:
